BY-LAW 669-96 TOWN OF MANNING

A By-law Of The Town Of Manning In The Province Of Alberta To Control Noise Within The Corporate Limits Of The Town Of Manning

Pursuant to the Municipal Government Act, 1994, Part 2, Division 1, Section 7, Chapter M-26.1 and amendments thereto, Manning Town Council may pass by-laws for municipal purposes respecting

- (a) the safety, health and welfare of people and the protection of people and property;
- (b) people, activities and things in, or on near a public place or place that is open to the public;

And Part 2, Division 1, Section 9, which gives the power to pass by-laws in general terms to give broad authority to councils and to respect their right to govern municipalities in whatever way the councils consider appropriate, within the jurisdiction given to them under this or any other enactment;

WHEREAS

The Council of the Town of Manning considers it expedient to pass a by-law for the purpose of prohibiting, eliminating or abating noise;

WHEREAS

The Council of the Town of Manning deems it proper and expedient to restrict and abate such activities which give rise to undue and unnecessary noise and;

WHEREAS

It is the intent of this by-law to control noise which disturbs the comfort or repose of other persons in the vicinity of such property or generally within the limits of the Town of Manning;

NOW THEREFORE

The Council of the Town of Manning, duly assembled, enacts as follows:

- The by-law shall be cited as the Town of Manning Noise Control By-law;
- 2. No person shall make, cause, continue to cause, or allow to be made any loud, unnecessary or unusual noise which either annoys, disturbs, injures, endangers or detracts from the comfort, repose, health, peace or safely of other persons within the boundaries of the Town of Manning effective between 11:00 p.m. and 6:00 a.m.;
- 3. No person shall allow property belonging to him or under his control to be used so that there occurs thereon or emanates therefrom any loud, unnecessary or unusual noise which either annoys, disturbs, injures, endangers or detracts from the comfort, repose, health, peace or safety of other persons within the boundaries of the Town of Manning effective between 11:00 p.m. and 6:00 a.m.;
- 4. Any person who contravenes any provision of this by-law or suffers or permits any act or thing to be done in contravention or in violation of any of the provisions of this by-law is guilty of an offence and shall be liable on summary conviction to the following:
 - a) For the first offence, a minimum fine of \$200.00 to a maximum of \$500.00;
 - b) For the second and subsequent offences, a minimum fine of \$500.00.

By-law 532 is hereby repealed. This by-law will come into effect on the final date of passing thereof.
