



TOWN OF MANNING, ALBERTA

BY-LAW 818-14

MUNICIPAL LIBRARY BOARD

A By-law of the Town of Manning in the Province of Alberta, to provide for the establishment of a Municipal Library

WHEREAS Section 3(1) of the Libraries Act, Revised Statutes of Alberta 2000, Chapter L-11, as amended (hereinafter referred to as the "Act") authorizes a Council to establish, by by-law, a municipal library board;

AND WHEREAS Section 4(1) of the Libraries Act, Revised Statutes of Alberta 2000, Chapter L-11, authorizes the appointment of not fewer than 5 and not more than 10 members;

NOW THEREFORE PURSUANT to the provisions of the Libraries Act, Chapter L-11, the Council of the Town of Manning, Alberta, in regular session duly assembled, enacts as follows:

SEVERABILITY

If any provision of this by-law is declared invalid because of any word, phrase, clause, sentence, paragraph or section of this by-law or any documents which form part of this by-law or an application thereof to any person or circumstance is declared invalid, the remaining provisions shall not be affected thereby, but shall remain in force.

SECTION 1 – SHORT TITLE

This By-law may be cited as the "Manning Municipal Library Board".

SECTION 2 – DEFINITIONS

- 2.1 "Act" means the Libraries Act, Revised Statutes of Alberta 2000, Chapter L-11, as amended or repealed and replaced from time to time;
- 2.2 "Administration" means the general operation of the Town of Manning, including without limiting the generality of the foregoing, personnel, financial and other related matters as permitted by the Act;
- 2.3 "Council" means the Council of the Town of Manning;
- 2.4 "County Council" means the Council of the County of Northern Lights;
- 2.5 "Municipal Board" means a municipal library board;
- 2.6 "Municipal Library" means a library that provides public library services under the control and management of a municipal library board.

SECTION 3 – ESTABLISHMENT

3.1 Council hereby establishes the “Manning Municipal Library Board”.

SECTION 4– APPOINTMENT AND DUTIES

- 4.1 The Municipal Library Board shall consist of ten (10) members; one member from Town Council, one member from County Council, and eight other members appointed by Council;
- 4.2 All members shall be proprietary electors of the Town of Manning or the County of Northern Lights;
- 4.3 The Library Board has full management and control of the municipal library, subject to any enactment that limits its authority.
- 4.4 The policies of the Municipal Library Board shall be governed by Parts 1 and 5 of the Libraries Act and Amendments and Regulations pertaining thereto.

SECTION 5 – REPEAL

5.1 This By-law hereby repeals By-law #301/68 and By-law #640/93.

SECTION 6 – EFFECTIVE DATE


6.1 This By-law shall come into effect the date upon third and final reading.
